**ELIGIBILITY**

*Kudzu's Annual Open Juried Exhibition* is open to all Georgia artists 18 years of age and older. Artists **must** be able to hand deliver artwork to The Rectory in Downtown Norcross.

**MEDIA CATEGORIES ACCEPTED**

We will consider two-dimensional and three-dimensional media for this exhibition. All artwork must be original, created by the artist. Artwork must have been completed within the last two years and not previously shown in any Kudzu exhibition.

*Accepted media:* acrylic, charcoal, colored pencil, digital art, fiber arts, gouache, graphite, oil, mixed media, mosaic, pastel, pen & ink, printmaking, photography, watercolor, ceramics, pottery, and sculpture.

*Not eligible:* work created in a classroom or under workshop supervision, reproductions, gicleés of original paintings, installations, or videos. Entries must not violate copyright laws.

#### ENTRY FEES

Kudzu Members: \$35 for up to 3 entries

Non-members: \$45 for up to 3 entries

**All fees are non-refundable.**

#### HOW TO ENTER

Artists may submit up to 3 entries in JPEG format. Please submit one file for each 2-D work. For each 3-D artwork, up to three images (two of work and one detail) may be submitted. **Submission does not guarantee acceptance into exhibition.**

#### **Pay online and email images**

To fill out the entry form and pay online, go to [kudzuartzone.org/open-juried-exhibition](http://kudzuartzone.org/open-juried-exhibition). Then email images to [submissions@kudzuartzone.org](mailto:submissions@kudzuartzone.org). In the body of the email be sure to include the artist's name, contact information, as well as the title of each entry submitted.

#### IMAGE ENTRY REQUIREMENTS

- Image resolution should be at least 300 ppi with a maximum 1,800 pixels on the longest side.
- Maximum file size 3MB.
- Label each image file as follows:  
Last name with first initial -TitleOfWork.jpg  
For example: **SmithL-FlightOfTheSeagull.jpg**
- For 3-D entries, detail images must include the word "detail" in the file name.  
For example: **SmithL-TheThinker-detail.jpg**

#### ARTWORK REQUIREMENTS

##### **2-Dimensional:**

- All 2-dimensional work must be framed or gallery wrapped, ready for hanging with wire in place.
- Artist's name, email, title, and phone number should be on the back of the artwork.
- NO GLASS. Plexiglas must be used (except pastel entries).
- Maximum size including frame may not exceed 48" in any direction. Minimum image size is 8"x10".
- Improperly framed pieces or those unsuitable for hanging will not be accepted.
- No sawtooth hangers will be accepted.

##### **3-Dimensional:**

- Must be able to be displayed on the floor or on a 12"x12" pedestal
- All 3-dimensional work that will sit on the floor is not to exceed 5 feet high and 24" in diameter and weigh no more than 75 lbs.
- Work to be displayed on a pedestal cannot exceed 12" in diameter by 30" high
- All mechanical pieces must be self-contained as electricity will not be available.
- Kudzu cannot guarantee special lighting will be available for judging or display.
- **Art that needs to be suspended from the ceiling will not be accepted.**
